Travel Plaza: Purchasing properties, collaboration with Fulton County. Discuss parameters for developing master plan

Truck Staging:

- Enforcement of no-parking rules alone cannot solve the problem. Truckers need temporary staging space while between deliveries in FIB.
- Understand process to restripe streets, plus enforcement and ordinance needs.
 - Does City own the roads we'd use? GDOT coordination.

Clean Power Toolkit:

- Discuss benefits of power toolkit to city
 - Incentivized investment leading to economic growth
 - Sustainability through promotion of green energy practices
 - Improving living standards in the city through access to clean power.
- How to add toolkit to City code (ie for entitlements process)
- Can/will the City promote it so people know about it and use it
